As a recent exhibitor at **Otley Show**, I now have pleasure in enclosing our Application Form for our forthcoming show on **Saturday, 20th May 2017**, details of which are given below. Please note that all trade stand proprietors and activity providers must enclose a copy of their current Public Liability Insurance Policy with an indemnity limit of £5m otherwise their application could be refused.

OUTDOOR TRADE STANDS

- ◆ Prices, sizes and ticket allocation listed overleaf.
- ◆ The minimum depth of a site is 20'
- ◆ Please allow an additional 5' on all sides for guyropes of marquees
- ◆ Please note all catering and confectionery rights have been allocated
- ◆ All products being sold must be specified on this form, failure to do so will result in refusal of entry on Showday
- ◆ Please ensure that all gazebos or tents are securely pegged
- ◆ Everyone entering the Showground must have a ticket – see over for additional tickets
- ◆ Please ensure you have adequate supplies on your stand as additional vehicles cannot be admitted to the showground throughout the day
- ◆ Electricity is not provided and only silent generators will be tolerated
- ◆ Security is not provided on the showground
- ◆ No loudhailers will be allowed
- ◆ No games of chance, Tombolas, or collecting buckets allowed

INDOOR CRAFT/TRADE STANDS

- ◆ Each site is 8' wide and 10' deep
- ◆ One 6' trestle table will be provided free, additional tables charged at **£6.00**.
- ◆ Electricity (subject to availability) will be charged at **£30.00**
- ◆ Exhibitors own unit must be no more than 7' wide
- ◆ Sites will be allocated when all sites have been let or, if not all let then after the closing date of 20th April

The Society reserves the right (without any reason being given) as follows:-

- ◆ To refuse any entry whatsoever whether prior to the closing date or not
- ◆ To cancel any entry which may have been accepted
- ◆ To refuse entry to the showground.
- ◆ To ask any exhibitor to leave the showground

In any such case, the liability of the Society shall be limited to the refund of the entry fee and the Society shall not under any circumstances be liable for any other loss suffered by the exhibitor, whether consequential or otherwise.
